

**ST. CYRIL OF JERUSALEM
PARISH RELIGIOUS EDUCATION PROGRAM
SAFE ENVIRONMENT COMPLIANCE REQUIREMENTS**

The Archdiocese of Philadelphia requires every parish to be in full compliance with the Commonwealth of Pennsylvania requirements for background checks and clearances. Archdiocesan policy requires all church personnel and volunteers to obtain background checks prior to commence working or volunteering services. Volunteers who may have regular contact with children must also obtain background checks prior to begin working or volunteering.

I. BACKGROUND CHECKS/TRAINING FOR VOLUNTEERS – at least age 18/PA Resident for LESS than 10 years

1. PA State Police Criminal background check – renewable every 5 years
2. PA Department of Public Welfare Child Abuse History Clearance – renewable every 5 years
3. FBI Fingerprint Clearance – renewable every 5 years
4. Attend the Child and Youth Protection Orientation (aka-Protecting God’s Children Awareness Session”
5. Read the “Addendum to “The Standards of Ministerial Behavior and Boundaries” (Information and Communication Technology) – sign acknowledgment form and submit to the parish Safe Environment Administrator.
6. Complete Mandated Reporter Training (online) – Submit Certificate of Completion

II. BACKGROUND CHECKS/TRAINING FOR VOLUNTEERS – at least age 18/PA Resident FOR 10 years or more

1. PA State Police Criminal background check – renewable every 5 years
2. PA Department of Public Welfare Child Abuse History Clearance – renewable every 5 years
3. Disclosure Statement – read/sign submit to parish Safe Environment Administrator
4. Attend the Child and Youth Protection Orientation (aka-Protecting God’s Children Awareness Session”
5. Read the “Addendum to “The Standards of Ministerial Behavior and Boundaries” (Information and Communication Technology) – sign acknowledgment form and submit to the parish Safe Environment Administrator.
6. Complete Mandated Reporter Training (online) – Submit Certificate of Completion

IV. SAFE ENVIRONMENT TRAINING - Two Part Program

PART ONE – “Protecting God’s Children” ... conducted by *VIRTUS* certified facilitators on the prevention of child abuse. The purpose is to increase participants awareness of the signs of child sexual abuse, the methods and means by which offenders commit abuse, and provides five easy steps to be employed to prevent child sexual abuse. Two videos are used in the program, “*A Time to Protect God’s Children*” and “*A Plan to Protect God’s Children.*”

The training facilitators incorporate policies and procedures for defining child sexual abuse, reporting child sexual abuse, screening/selection of employees, and victim advocacy.
